## 2022 FIM EWC DISCLAIMER FOR PERMANENT MEDIA PASS HOLDERS

The use of the 2022 FIM Endurance World Championship (FIM EWC) permanent media pass, which is valid for all the rounds of the 2022 FIM Endurance World Championship, valid for paddock or pit lane access and provided by Discovery Sports Events, is subject of the media accreditation procedure, including acceptance of the terms and conditions below (referred to below as "**General terms and conditions for pass holders**") being followed in full. Furthermore, please note that by receiving and using this permanent pass, you declare that you have carefully and fully read and accepted the general terms and conditions for pass holders, and that failure to comply at any time with such terms and conditions may determine your expulsion from the racetrack and the withdrawal of your permanent pass by Discovery Sports Events' media delegate and/or manager(s).

### General terms and conditions for permanent pass holders

#### 1. Subject matter

1.1 Discovery Sports Events hereby intends to limit the risks to which permanent pass holders may be exposed during the events taking place at the racetracks included in the 2022 FIM EWC.

#### 2. Obligations of permanent pass holders

2.1 You hereby confirm that you have read and fully understand these terms and conditions and that you agree that the permanent pass is strictly personal and cannot under any circumstances be sold, lent, rent, given and/or in any way transferred to anyone other than you. The permanent pass shall not be altered or defaced. Use of the permanent pass for commercial purposes is strictly forbidden.

2.2. Permanent pass holders who, in the capacity of visitors, access the work areas called "**Pit Lane**" and "**Paddock**" (hereinafter referred to as the "**Areas**") hereby agree that they will do so at their own risk, releasing Discovery Sports Events from any responsibility for damages or injuries that may be caused to the same holders or to any other persons or things present in the Areas.

2.3 FIM EWC events pose certain risks for permanent pass holders due to a number of potentially hazardous situations and areas and, consequently, the participation in these events requires that each pass holder acknowledge and accept the possibility of being exposed to personal risk. To that end, you hereby expressly acknowledge, fully assume and accept that the activities of the event(s) are very dangerous and involve the risk of serious injury and/or death and/or property damage.

2.4 Permanent pass holders must have an appropriate insurance. A copy of the insurance must be provided to Discovery Sports Events within the media accreditation procedure.
